## **Points of Note:**

1. States do not need to use Pantone brand colours, as some manufacturers use other colour systems.
2. States must use the manufacturer's colour system, selecting the colours that most closely match these Pantone colours.
3. There will be no variation to these set colours other than in case of #2. above. The colour itself will not change.
4. 'B Teams' to wear opposite colours
5. All 'mockups' to be approved by the Chief Referee for in-pool visibility and adherence to the provided colour chart prior to manufacture.
6. Please ensure you have one of your contrast colours clearly visible across bathers to avoid similarity in the pool. For example, solid panels down both sides of bathers, **or** 'splash' of colour on the bathers themselves (logo/pattern) - please avoid, block colour with fine trims that are hard to see.
7. Follow all other uniform policy guidelines

## **CAPS**

1. Caps to be dark/light state colours as indicated in table above  
For example: South Australia - Dark cap is Pantone Blue 295 C with Pantone 137 C font. Light cap is opposite
2. The caps can be solid colour or have a pattern/watermark, provided the use of a pattern does not substantially affect the primary colour (i.e. max 10% of secondary colour - see example below)
3. NO Logos - player name and state name to be located as per example provided.
4. Player Number to be located on both the cap peak and cap crown/back in the opposite cap colour.
5. If ear guards are not available in the same cap colour, they must be Black for dark and White for light.....

## **Bather and Cap Requirements – Nationals 2027 (as per policy)**

### **1. Bather Requirements**

All *bather* requirements must be fully implemented across **all state teams** for **Nationals 2027**.

### **2. Cap Requirements Exemption/Extension**

**a.** *Cap* requirements must be fully implemented across **all states** for play in **2028**, or at the **next purchase of National Team caps**, whichever occurs first.

**b.** In the meantime, only current approved caps or newly approved caps to be used. In other words, only the 2 different style caps permitted, as the team's transition from old to new over the 2-year period. **Nationals 2028 MUST** have all caps policy compliant.



ALL colour combinations, points of note and cap design have gone through a rigorous design and consultation process with the UHA Chief Referee, UHA Tournament Director, the AUF and UHA executive to ensure alignment with the new [AUF Uniform Policy](#).
